2. **Job Category: Plantation Sector:** General Work Laborer (Palm Oil Trees) (Nature of the Job: **Planting, Plucking the Palm Oil Fruit, Weeding, Spraying Insecticide, Pruning, Watering Plants in the Nursery, Loading the Palm Oil Fruit onto the Lorries for Transportation; etc**)
2. Type of Sector: Oil Palm Plantation
3. Age: 21- 36 yrs old Only
4. Contract Period: 3yrs
5. Gross wages (per month)Basic Salary :**RM1, 000.00 – Minimum Salary Per Month**(As Per Malaysian Government wages). **With Overtime, the Candidates are able to earn, RM1, 400 to RM1, 800, Per Month, depending on their hard work.**
6. Working days: Monday to Saturday. Sundays & Public Holidays rest day
7. Regular working hours: 8 hours plus 2 hours Overtime Daily
8. Overtime: In accordance with Malaysian law
9. Workmen Compensation: In accordance with Malaysian law
